Masking Rule Types

The internal regular expression tester now tests for length rather than complexity.

By default there is a 1,000-character maximum on regular expressions.

Security Library Updates

We updated several libraries to resolve any critical or high vulnerabilities reported by Snyk.

Some notable updated libraries include:

- Spring Boot to version 2.7.9, which bundles Apache Tomcat 9.0.71
- Replaced Apache Log4j with Reload4j version 1.7.36

NOVLT Tokenization

This release includes improved performance for NOVLT tokenization.
